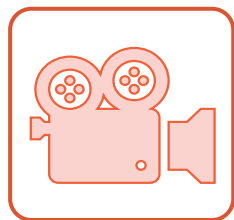




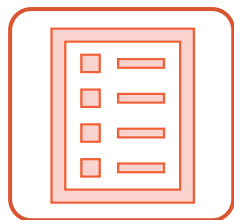

Overview:

HB 8, Passed during the 89th, 2nd Special session requires the Texas Education Agency (TEA) to transition the current summative assessment into an instructionally supportive assessment program by SY 2027-28.

The last administration of the current STAAR test will be Spring 2027 for 3-8 and December 2027 for EOC.

Purposes:

The agency shall create and implement an instructionally supportive statewide assessment program that:



(1) provides for **progress monitoring**;



(2) is **balanced, innovative, and streamlined**; and



(3) is **based on essential knowledge and skills** adopted by the State Board of Education under Section 28.002.

Some HB8 requirements begin in SY2025-26

- ✓ Teachers will be paid a daily rate for educator reviews (i.e., EIRs, EPRs)
 - Starting this summer, educators can be paid \$200 per day
- ✓ Monday Testing Rule Repealed
 - Districts may choose to test on the first Monday of a testing window
- ✓ Test Anxiety Mitigation
 - Language added to Test Administrator Manuals
- ✓ Family Portal Results In One Click
 - TexasAssessment.gov updated
- ✓ District Results Notification
 - 98% of districts already utilize SSO
- ✓ Automatic Rescore Process
 - Process began two years early w/ December 2025 administration

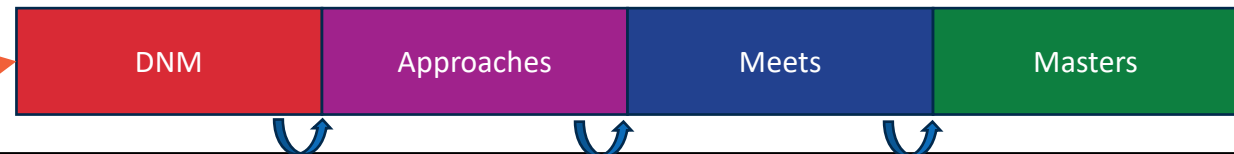

ECRs on RLA assessments when students are **1 point away** from the next Performance Level will be automatically rescored by hand.

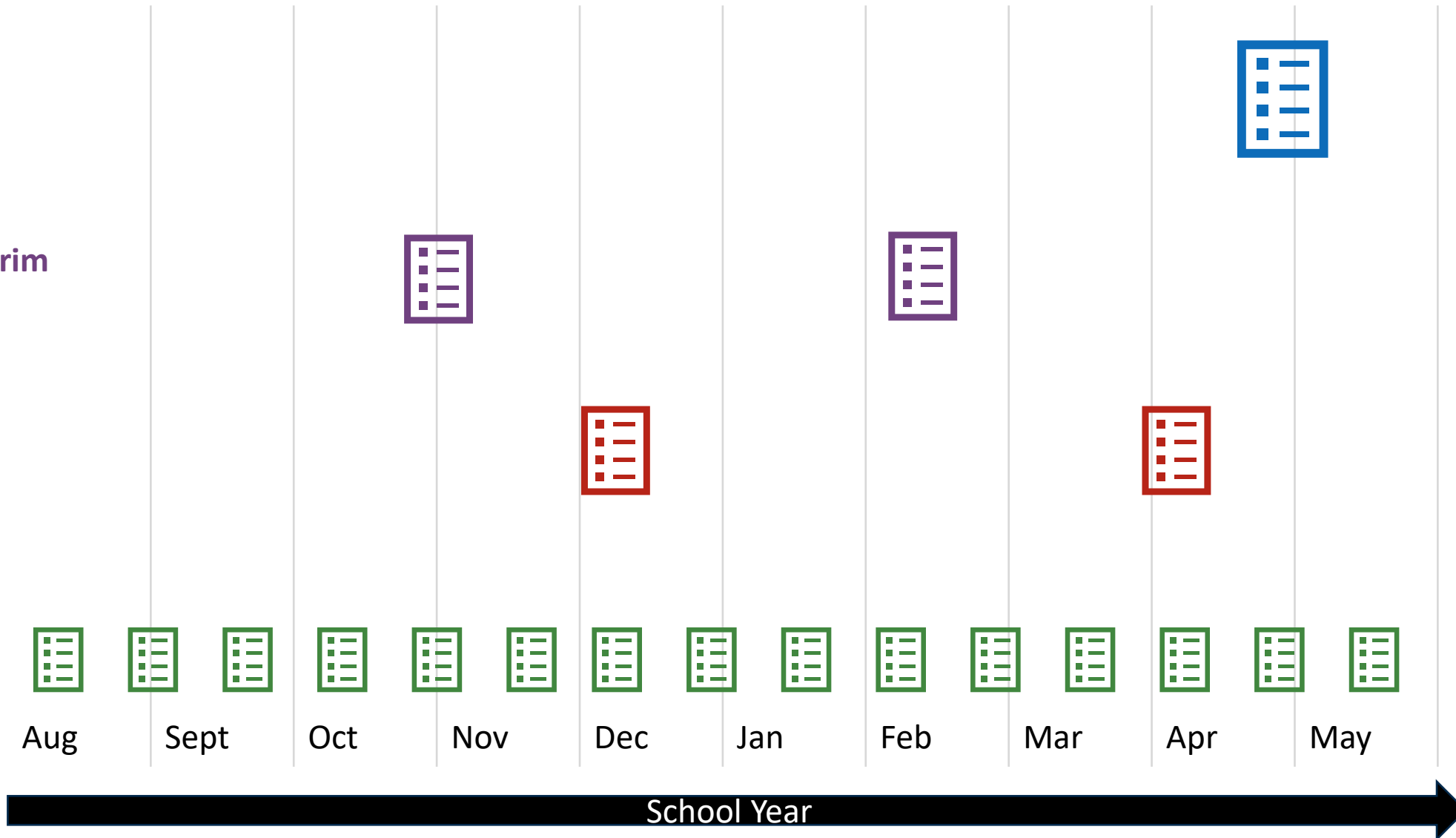
The local assessment landscape is highly varied, and implementation fidelity can be inconsistent

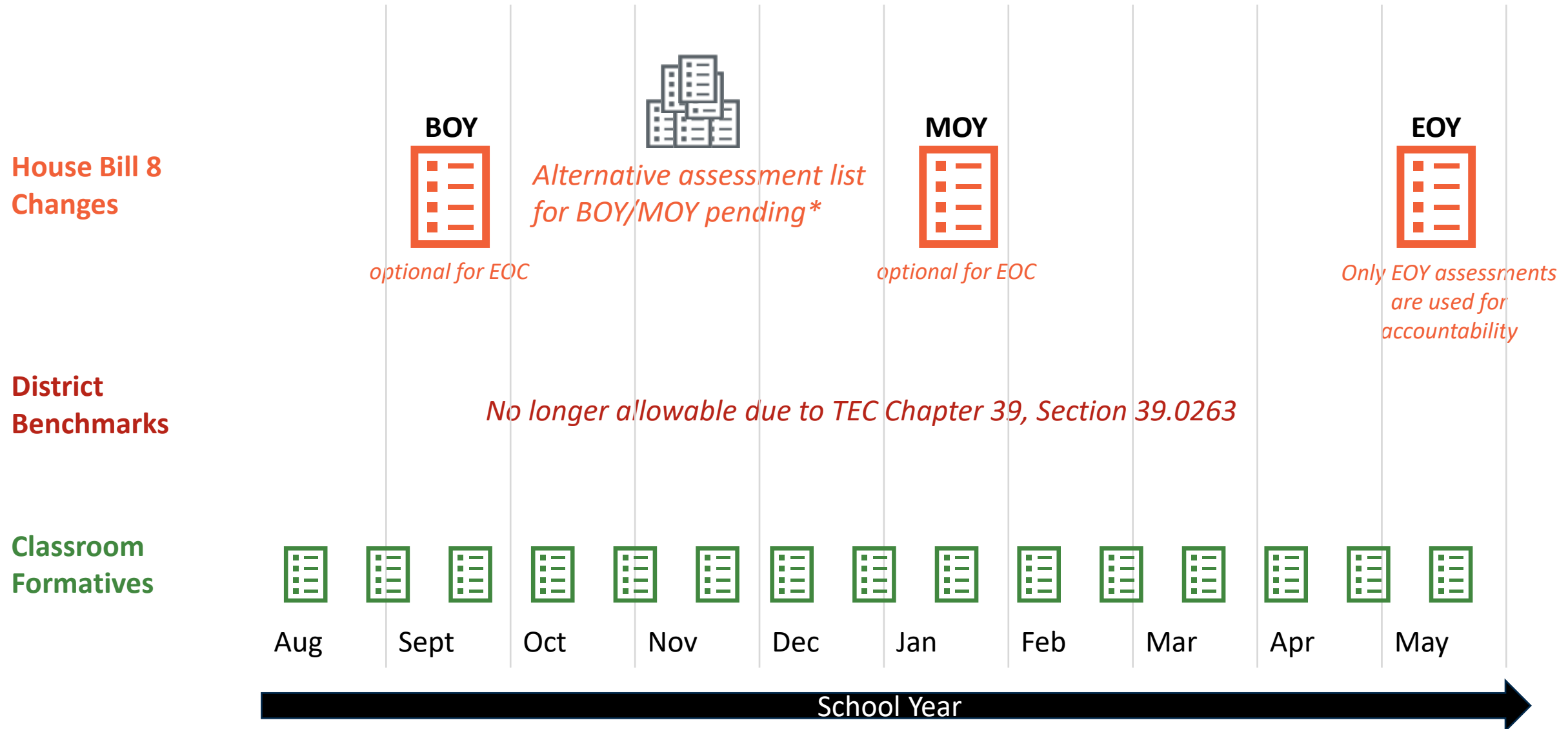

The future state with HB8 (SY27-28) features a more streamlined approach, recapturing student instructional time



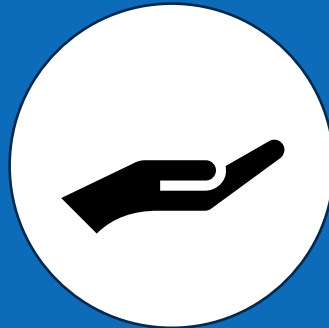

The Student Success Tool (SST) builds on the key strengths of STAAR



Item Bank Vetted By Texas Teachers

All items must be approved by a committee of current Texas public school teachers in each grade and subject, with agreement from committee members that questions are tightly TEKS-aligned



Universal Accessibility

The most comprehensive set of accommodations are available on the online platform, intended to mimic accommodations provided during instruction



Unparalleled Transparency

EOY items and student responses are made visible to educators and parents so that everyone can see exactly how well each student performed (via [TXassessment.gov](https://txassessment.gov))

These strengths will serve as the foundation moving into the new assessment system

The SST will bring improved administration and data of assessments, with fast turnaround of results

1



Reduced Test Administration Burden

Certain test administration practices eliminated/ streamlined for tests to be administered with minimum disruption to campus learning environments and bell schedules

Rapid Results

EOY results available within 48 hours of the assessment window close; Results for BOY/MOY provided the same day a student takes the assessment (by second year of SST)

Norm-Referenced Within Year Growth

Reports show longitudinal student-level growth compared to other similar students within the state

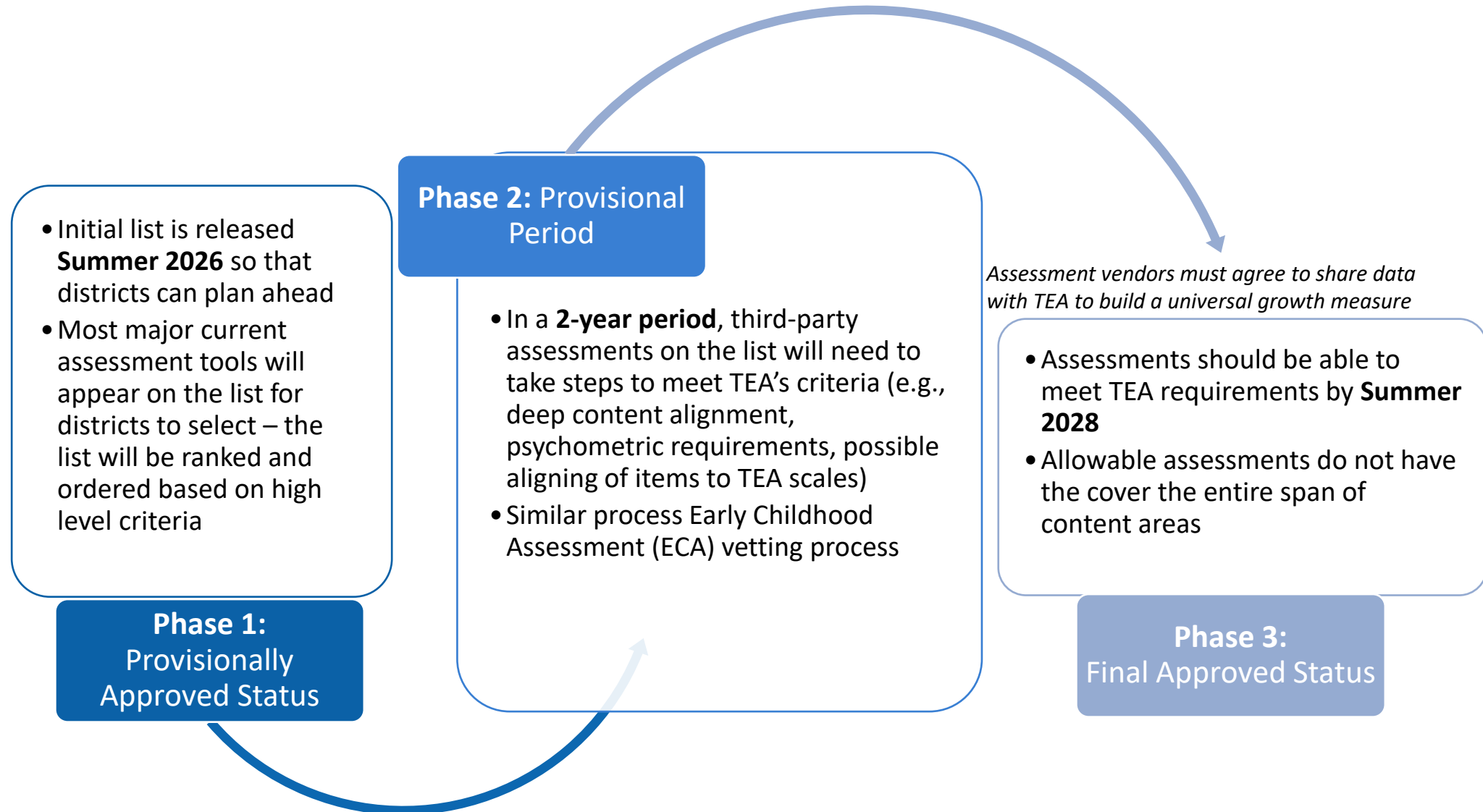
Multiple Data Platform Integrations

Multiple methods are available for accessing results

A phased process will need to be implemented for developing an approved alternative assessment list



Note: Every third-party assessment would have to undergo a multi-stage process to be a certified alternative for SST, even outside of the initial timeline

**Fixed forms for each stage (BOY, MOY, EOY) will be developed to accommodate paper, PES, Braille, and ASL administrations*

The updated test design include shorter, individualized assessments and RLA improvements

Adaptive BOY and MOY Tests

Item-level and passage-level (RLA) adaptive tests that can adjust to student level mastery of TEKS; Data will support differentiated instruction, acceleration, and MTSS

2



Shorter Test Length

As much as 30% shorter per testing event, compared to the STAAR

3



Shorter Reading Passages

Students will experience a lighter reading load, with passages around half the length of STAAR passages

4



Writing Improvements

ECR scoring will move from a 10 pt. rubric to 6 pts, with zero scores reserved for only blank or nonsense responses; SCRs eliminated; Auto ECR rescore process implemented

Fall 2026

- One-stop shop webpage
- Implementation roadmap for test coordinators
- Test design blueprints and rubrics
- Reporting design feedback 
- Cognitive labs for students 

Spring 2027

- Final reporting tools and score reports
- Embedded field test (legacy and new RLA design)
- **Standalone field test**
- Transition report for the legislature
- Trainings for educators

Fall 2027

- Go-live for BOY/MOY
- Family portal results
- Digital delivery of reports

Spring 2028

- Go-live for EOY
- Release of full EOY accountability data reports (delayed due to standard setting)
- **Standalone field test**

- May include in-person question-and-answer discussions

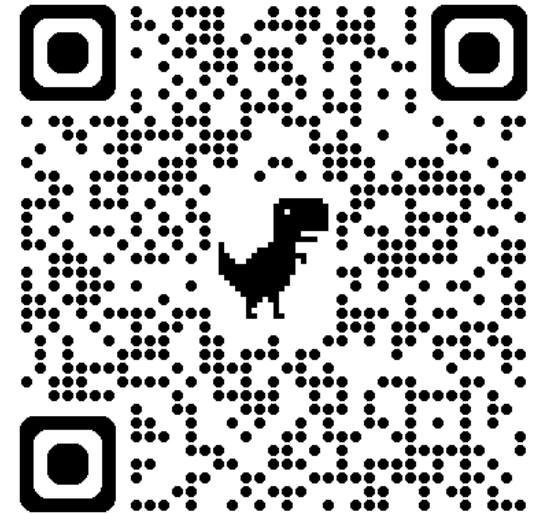

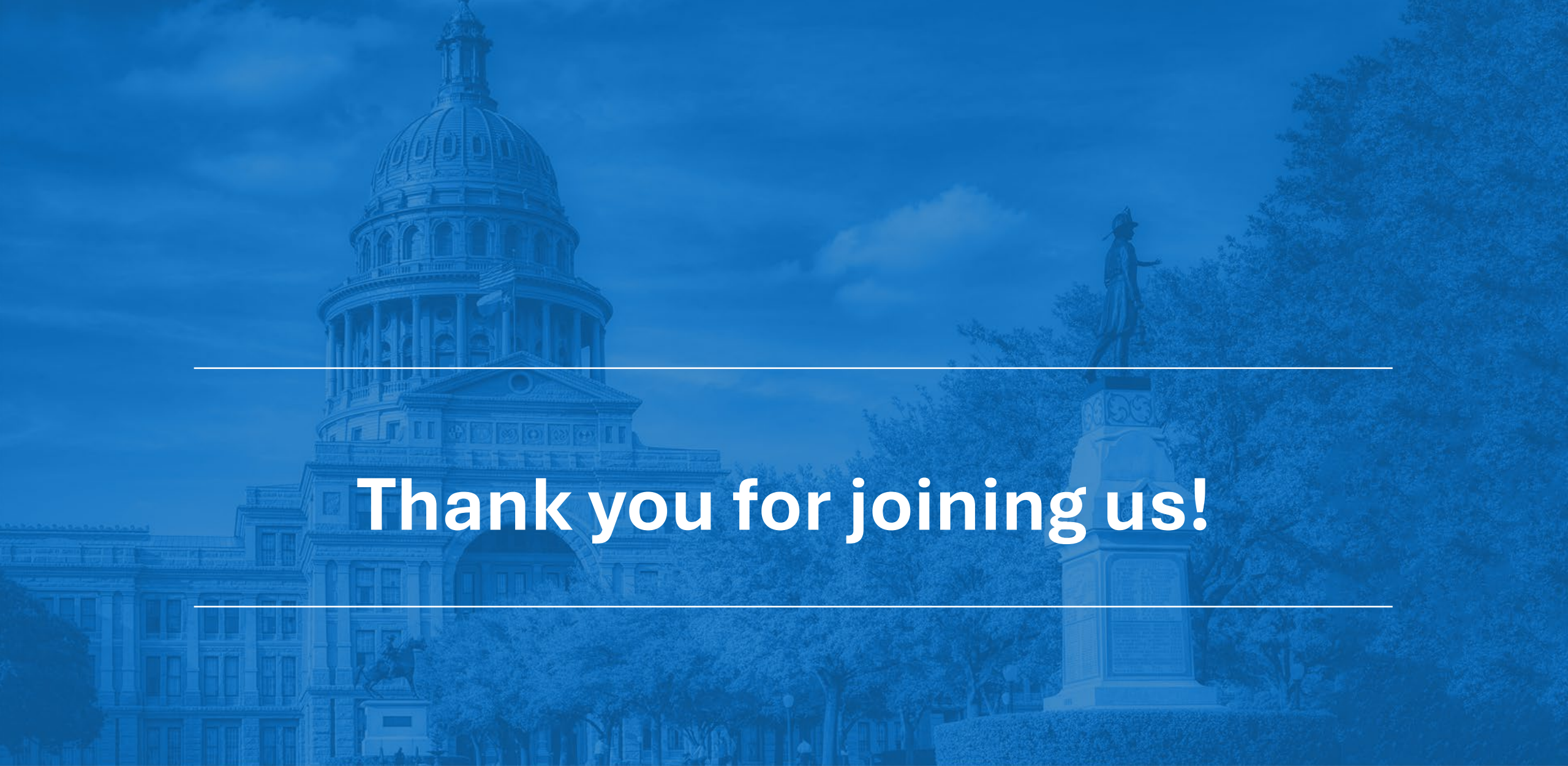
