# Overview

## Introduction to APEX

APEX is a Texas Education Agency Login (TEAL) application that must be used to notify the Texas Education Agency (TEA) of all nonpublic or non-district operated day program placements\* or nonpublic residential placements, in accordance with [19 Texas Administrative Code \(TAC\) §§89.1094](#) and [89.1092](#).

*\*Throughout this document, all placements that meet the definition of a nonpublic or non-district operated day program outlined in 19 TAC §89.1094 will be referred to as nonpublic day, or nonpublic.*

APEX is intended to serve several purposes related to state reporting requirements for nonpublic placement programs, as well as serve as an entry point to state and federal funding associated with these types of placements. APEX is also used to submit High Cost Fund (HCF) applications to request potential additional, optional funding for qualifying nonpublic day and nonpublic residential placements, and in district students. The information in this manual will help the user understand the general navigation and operation of APEX.

Local Educational Agencies (LEAs) are required to:

- Use APEX to notify TEA, within 30 calendar days, of LEA nonpublic day and nonpublic residential placements of students with disabilities;
- Adhere to all guidelines as stated in this manual; and
- Understand and follow the nonpublic placement program requirements as outlined in the [Nonpublic/Non-District Operated Program Guidance](#) manual, as well as any additional information and guidance provided regarding APEX utilization.

## System Requirements

The Texas Education Agency implemented [new browser requirements](#) in 2021 related to a technology initiative to enhance security for web-based applications.

Beginning April 15, 2021, TEA supports the current version of the [Google Chrome browser](#) to access applications such as eGrants and APEX. Internet Explorer should not be used for accessing these web-based applications due to functionality no longer being available, or the application may not work as expected.

# Texas Education Agency Login (TEAL) Portal

To access and log into APEX, the user must have a username and password for the Texas Education Agency Login (TEAL) Portal. To create a TEAL account, go to the [TEAL](#) webpage and click on **Request New User Account** and follow the steps to complete the process. For detailed instructions, visit the [Requesting a User ID](#) webpage.

**Note:** When completing TEAL account requests, please use your work-related email address rather than your personal email address for the email field.

Once a TEAL account is created, the user must request access to the APEX application through the TEAL Self-Service menu under **My Application Accounts**.

## Creating an APEX Application Account / User Roles

**Step 1:** Navigate to [TEAL](#) and enter the TEAL username and password you have been assigned and select **LOGIN**.

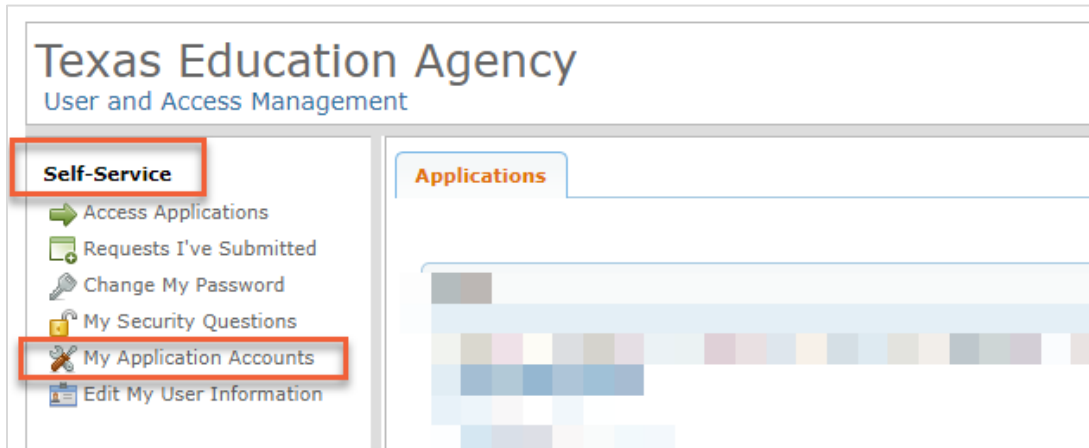

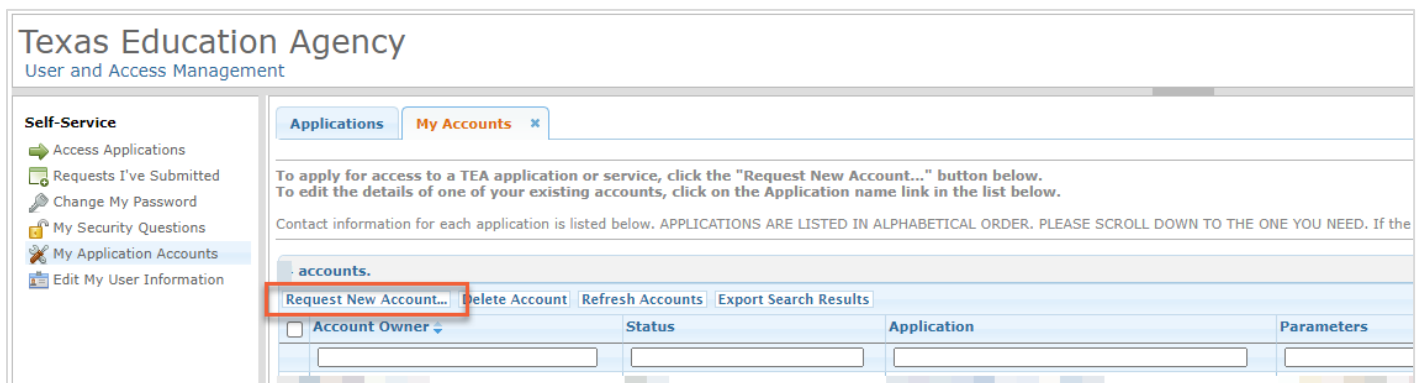

**Step 2:** You will see your TEAL landing page that lists **Self-Service** options along the left-hand toolbar and applications for which you already have access listed under the **Applications** tab to the right. From the **Self-Service** toolbar, click on **My Application Accounts**.



**Step 3:** You will now see the **My Accounts** tab open. From here, select **Request New Account**. After you select **Request New Account**, TEAL will display a full list of available applications shown in alphabetical order. Choose **APEX**. Upon entry, the user will see a screen with the level of access, or roles, and the campus(es) for which the user is assigned. Click on the access level link to open APEX.



**Step 4:** Next, enter your employing organization in the text entry field. Type the name of the organization (e.g., the local educational agency or the education service center) for which you are requesting access to the APEX Application.

**Step 5:** To complete the request in TEAL, choose the appropriate user access role under **Roles & Parameters** and select **DONE**.

- The user role for LEA personnel, including all single member districts and special

education shared services arrangement (SSA) fiscal agents, is **LEA Representative**. If you are a member of a special education SSA, your fiscal agent will submit the APEX application on your behalf.

- The user role for Education Service Center (ESC) staff is **ESC Viewer**.

**Step 6:** Once notified that your access has been approved, you will see the APEX application in the list of **Applications** when you log back into TEAL. Your applicable role will be displayed.

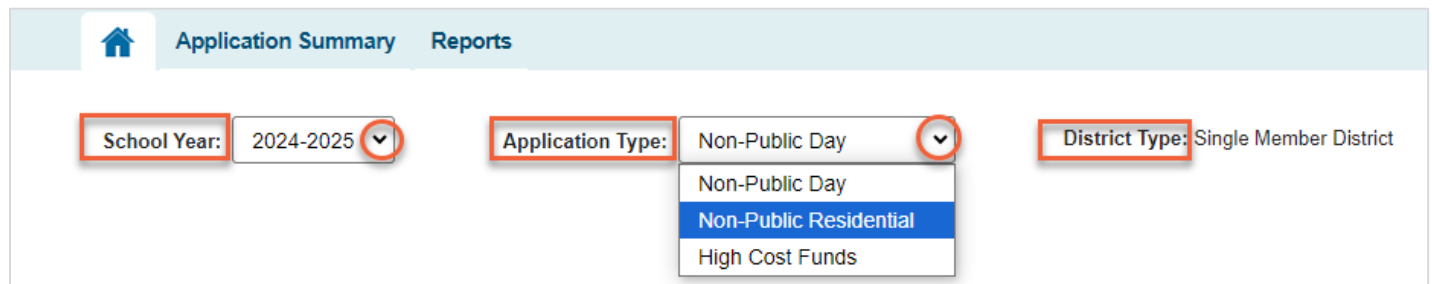

## General APEX Navigation

APEX is designed to have uniform navigation and a consistent look and feel on every screen. The **Username** and level of access (**Role**) is displayed in the upper left corner on every screen. In the upper right corner, you can click **Help** to access the TEA [Special Education in Nonpublic Programs](#) webpage for resources or click **Exit** to exit the program.




The APEX home page has an **orientation bar** across the top of the page that indicates the **School Year**, **Application Type** (Nonpublic Day, Nonpublic Residential, or High Cost Funds), and **District Type** (Single Member District or Fiscal Agent.)

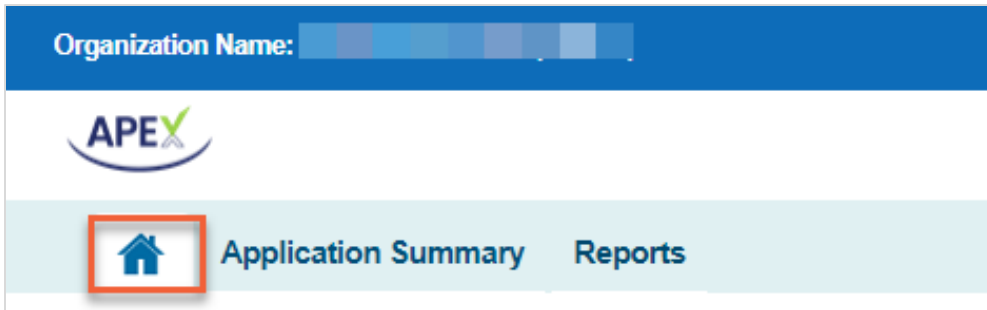


The **School Year** automatically defaults to the current school year. A user will be able to access APEX data for up to five school years if applications were entered in APEX in those preceding years.

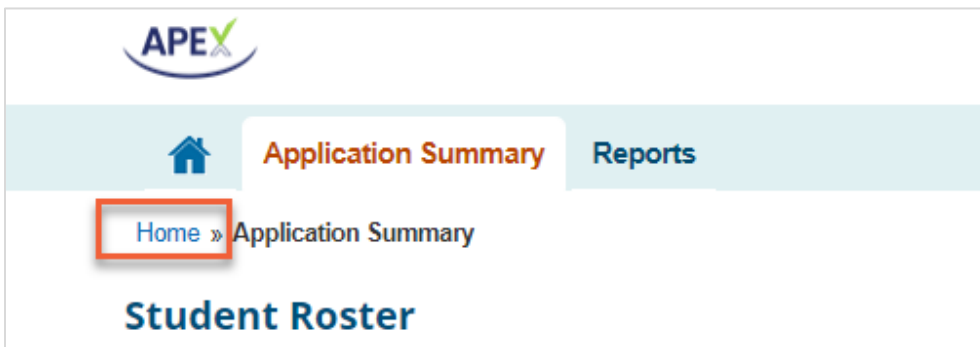
**Note:** APEX was initiated in 2021-2022. To access the previous years in APEX, choose the appropriate program year in the **School Year** drop down box. **Prior year** data is **read-only**. A user can only **view** data and **run reports** from prior years.

Most pages in APEX have a **navigation bar** with tabs to take the user directly to different pages in the system.

The navigation bar includes a  icon which the user can click to immediately return to the home page.



Breadcrumbs are another useful navigation feature of APEX. Users can click on the **hyperlinked page name** displayed to the left of the current page name to return to the previous section. In this example, while the user is on the **Application Summary** page, the user can click on the **Home** hyperlink to return to the Home page.



## APEX Application Summary Page and Student Roster

Each application type includes an **Application Summary** page. The Application Summary page for **Nonpublic Day and Nonpublic Residential** applications includes a **Student Roster** specific to that application type and at-a-glance details about student **Placement Status, Application Status, Facility Status, and Submitted Date**. If an application is in Submitted or Finalized status, this page will also include an **Amend** button.

Facility status code explanations and application **Add** and **Delete** buttons are located below the student roster. A **Search** bar is located on the right above the student list.

For special education SSA fiscal agent users, an additional drop-down menu will allow the Fiscal Agent user to choose a member district within the SSA. The system will default to listing all applications submitted for the SSA if a specific SSA member district is not chosen.

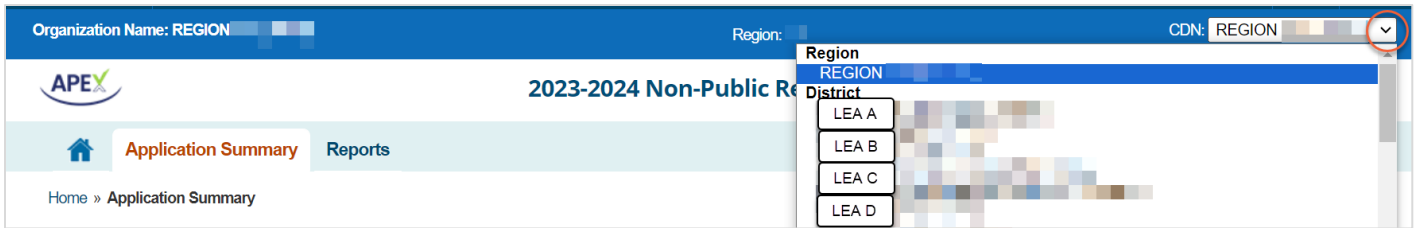

**Facility Status 1 (FS1)**, represented by a green box, indicates that the facility is currently approved for new placements. *The LEA must still meet all application and notification requirements for student placement. TEA approves APEX applications on an individual student basis.*

**Facility Status 2 (FS2)**, represented by a yellow box, indicates that the facility is currently approved for *continuing placements only*. LEAs may continue existing students' placements at the facility but may not contract with the facility for the placement of new students.

**Facility Status 3 (FS3)**, represented by a red box, indicates that the facility is not currently

approved as a nonpublic program. *The LEA must follow TEA procedures to engage in the initial approval process if this is a “not-yet-approved” facility; the LEA must meet TEA timelines to remedy noncompliance or make a change of placement if this is a previously-approved facility with revoked approval.*

## APEX Help

The APEX **Help** button is located on the top right of the screen.

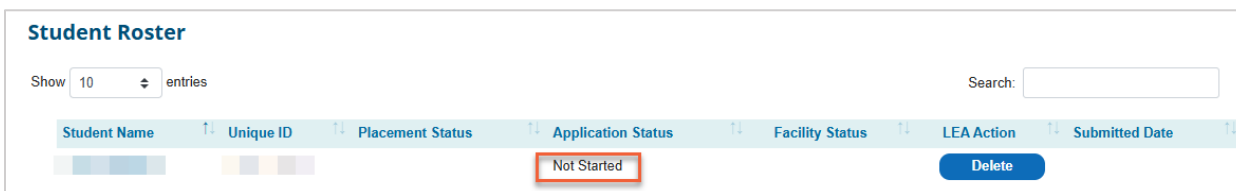

# Entering Day/Residential Applications

## Students with Application Status of Not Started

When the APEX application opens for submission each school year, students with Nonpublic Day or Residential applications from the previous year will automatically appear in the new year's **Student Roster** with an **Application Status** of **Not Started**.



Click on the student's hyperlinked name and perform data entry applicable to the current school year.

Refer to instructions in the **Adding a Student** section for guidance on completing the various sections of the application.

Refer to the **Deleting Students** section if the student is no longer placed at the facility during the current year. Only delete the student if they have no current-year nonpublic enrollment (e.g., withdrew before August 1.)

## Adding a Student

To add a new APEX application for a student placed in a nonpublic day or nonpublic residential facility, based on an admission, review, and dismissal (ARD) committee decision, first click **Add** on the **Application Summary** page for the specific application type (Nonpublic Day or Nonpublic Residential).

**Note:** *The Nonpublic Day application is used for placements described in [19 Texas Administrative Code \(TAC\) §89.1094 Contracting for Nonpublic or Non-District Operated Day Placements for the Provision of a Free Appropriate Public Education \(FAPE\)](#).*

## Entering Student Information

In the **Student Application** page for a specific student, the Unique ID, student first and last name, date of birth, and assigned gender auto-populate from the Texas Student Data System (TSDS). Enter the **Original Date of Placement** indicating the date the student **first entered the facility** and choose the student's **current** placement status from the drop-down menu for **Placement Status**. This process is the same for both Nonpublic Day applications and Nonpublic Residential applications.

## Entering Funding Information for Day Applications

**Step 1:** Enter the **Contract From** and **Contract To** dates to indicate the beginning and end dates of the current contract.

The contract dates and cost amounts entered in the APEX application must be **specific to the student**. For example, if your contract is for a “seat” cost for the entire year and the specific student is not receiving services the entire year, the dates and costs entered in the APEX application must be limited to the dates the specific student received services at the facility and the prorated cost for those dates of service.

**Dates must fall between 8/1 through 7/31 of the current school year.**

**Note:** For both Nonpublic Day and Nonpublic Residential applications, **contract dates that extend beyond the regular LEA school year through 7/31 may only be included in the APEX application if the student’s Individualized Education Program (IEP) recommends summer Extended School Year (ESY) for that school year.**

**Step 3:** Next, use the drop-down menu to select the student’s **Instructional Setting**.

**Note:** The instructional setting code affects the methodology used by TEA’s State Funding division when determining the Foundation School Program (FSP) special education allotment for the education cost in accordance with [Texas Education Code \(TEC\) §48.102](#) and [19 TAC §89.1005](#). Therefore, it is imperative that the instructional setting code is accurate and consistently applied in the student’s IEP, in the LEA’s local attendance accounting system, in TSDS Public Education Information Management System (PEIMS), and in the APEX application.

**Step 5:** Select the appropriate box to identify whether the LEA or the facility provides educational services listed in the student’s IEP.

**1 Provision of Education Services**

Education Services are provided by the LEA; if education services are provided by the LEA in which the facility is located, an agreement for special education service must be provided

**Step 6: Line #2 Estimate of Education Services** does not require data entry. The system will auto-calculate the number of months and Full Time Equivalent (FTE).

On **Line #3**, enter the **total number of instructional days in the contract for nonpublic day placements**. The system will auto-calculate the **Daily Rate** once the application is saved.

On **Line #4**, enter the **Total Contract Cost**.

*Prorated Contract Cost:*

Applications submitted past the required **placement notification deadline** identified in guidance on the TEA [Special Education in Nonpublic Programs](#) webpage will be considered for **partial funding** based on the date the APEX application is submitted, rather than being based on the contract start date. If the application is submitted late, the system will auto-populate the **Prorated Contract Cost** field with the reduced amount. If the application is submitted within the required timeframe, the **Prorated Contract Cost** field will be blank. The **Prorated Contract Cost Override** field is for TEA use only.

## Entering Funding Information for Residential Applications

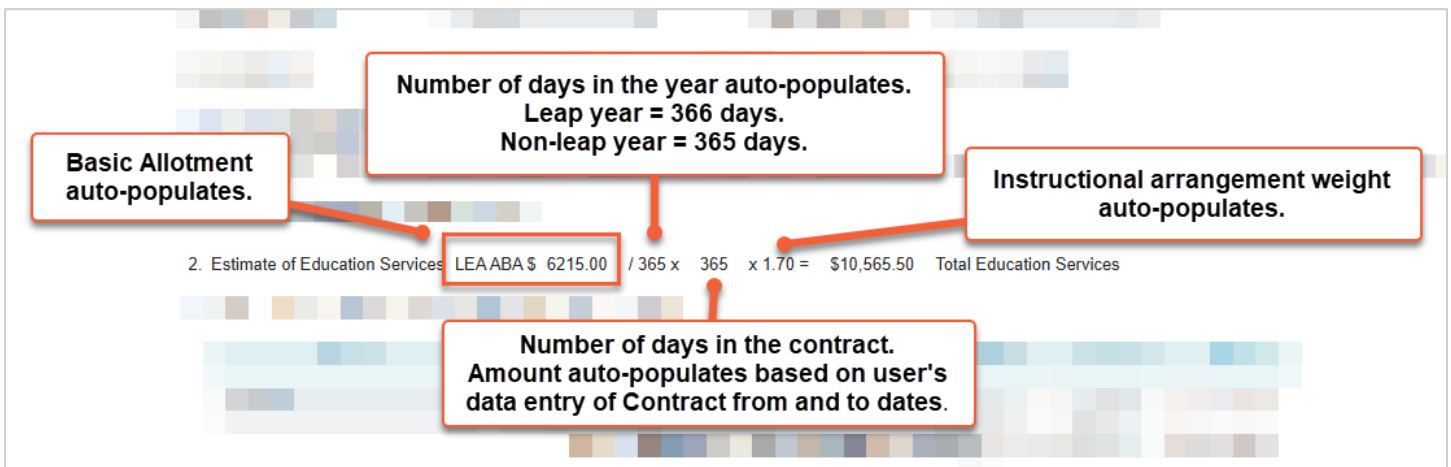
Procedures for entering funding information for Nonpublic Residential applications are similar to the procedures for entering funding information for Nonpublic Day applications in the previous section, with the exception of **Step 6**.

**Step 6: Line #2 Estimate of Education Services** does **not** require data entry, *effective with the 2023-2024 application*. All elements in Line 2 auto-populate.

**LEA ABA** (Basic Allotment) amount: In accordance with [House Bill 2 \(HB 2\) Foundation School Program \(FSP\) Funding Formula changes](#) from the 89<sup>th</sup> Legislature, the Basic Allotment (BA) increased from \$6,160 to \$6,215, effective with the 2025-2026 school year. The Basic Allotment is subject to change based on future state legislation.

The APEX system auto-calculates the dollar amount of the **Total Education Services** based on the formula displayed.

**Formula:** The LEA ABA amount is divided by the number of days in the year. During a leap year, the formula will be based on 366 days. During non-leap years, the formula will be based on 365 days. The result is then multiplied by the number of days in the contract, which the system auto-populates based on the contract dates entered in the application. The result is then multiplied by 1.7, the instructional arrangement weight in accordance with [TEC §48.102](#) and [19 Texas Administrative Code \(TAC\) 89.1092](#).



On **Line #3**, enter information for related services, speech, supplemental and other support services **identified in the student's IEP and listed in the contract**. You can click **Add Row** multiple times to list multiple services. Choose the **Service** and **Service Type** from the drop-

down menus and manually enter the **Number of Sessions/Interventions** and **Unit Cost** obtained from the contract. The system will auto-calculate the subtotal for each type of service and then auto-calculate a total amount for all services entered in this part.

**Note:** If the contract's cost analysis indicates services at no charge, please do **not** enter those services in Line 3. Only enter services with an actual cost. The facility might list those services in the contract so you are aware of all services being provided and can ensure IEP requirements are being met.

On **Line #4**, enter the **Daily Rate** for residential services from the contract. The system will auto-populate the **Total Days** based on the contract dates entered in the application and will auto-calculate the **Subtotal** for the cost of **Residential Services Provided**.

**Note:** The **maximum allowable daily rate**, as recommended by the Texas Department of Family and Protective Services (DFPS) for **General Residential Operation Intense** service level of care, is displayed in the **Not to exceed** portion of Line 4. This rate is subject to change. The APEX application will display the **Not to exceed** amount applicable to that application year. Do not enter a rate that exceeds the maximum allowable daily rate.

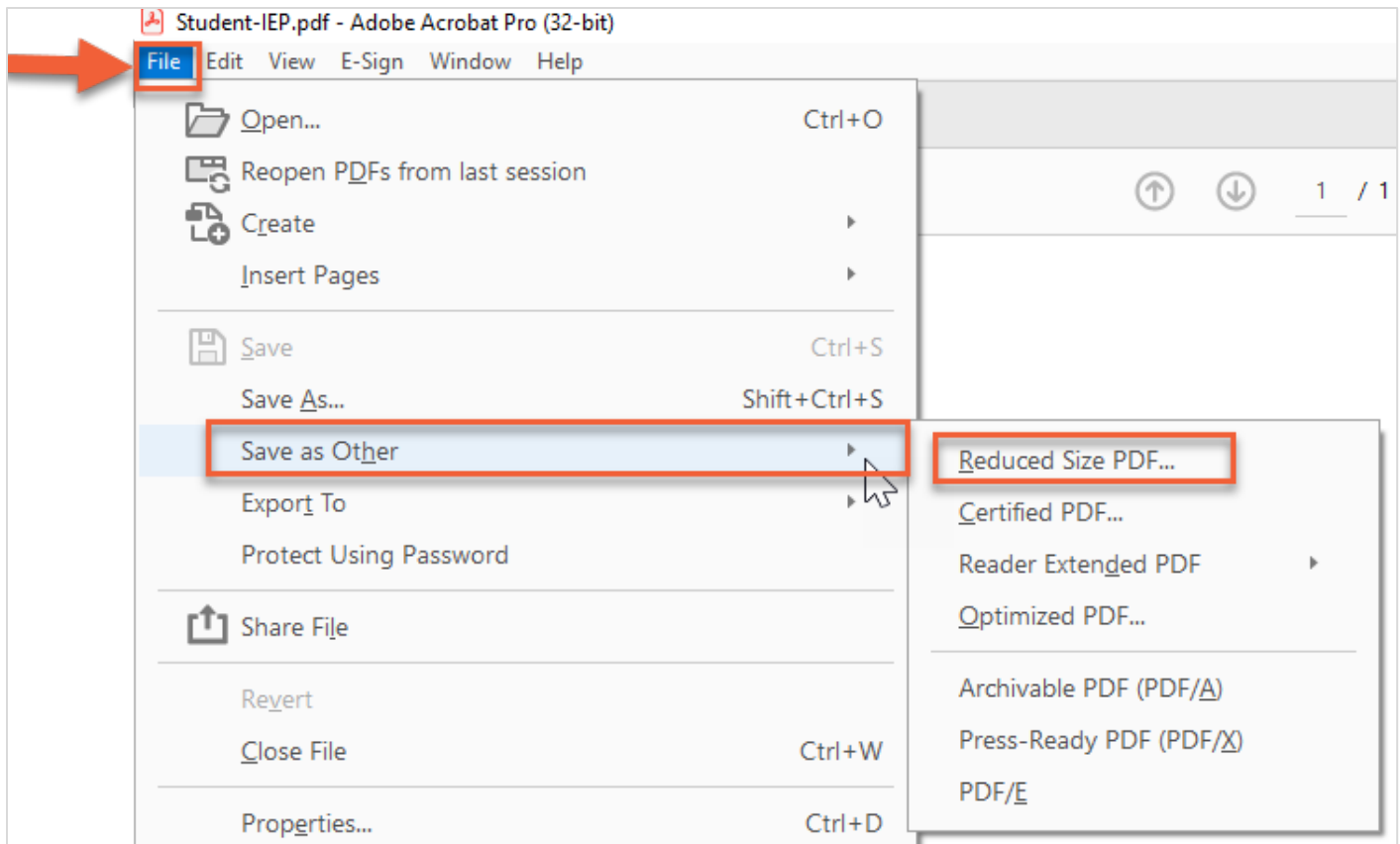

### File Upload Tips:

- Ensure you are using the most recent Google Chrome internet browser.
- Clear your browser's cache.
- When you name files on your computer that you plan to upload, keep the name short and don't use spaces in the name.
- Ensure the attachment has a valid extension, such as .pdf or .docx.
- If scanning files, create PDF documents rather than .jpg files\*.
- Rescan the document to save on your computer and upload the rescanned version if the original version won't upload.
- If possible, rather than printing and scanning files, it's best to **Save as PDF\***.
- Reduce the file size of PDFs prior to upload by selecting the **File** dropdown in the header of your document and then selecting **Save as Other** and then selecting **Reduced Size PDF** (see graphic below). **\*Note:** Not all PDFs are the same. Acrobat doesn't produce its own documents. Instead, the PDFs originate from other programs or sources, such as exported documents from Microsoft Office files, Forms (Adobe Designer, XFA PDFs, Word to PDF), Portfolio PDFs, Google Doc PDFs, Google Doc PDFs, Scanned PDFs, and Print to PDF. When converting your document to PDF, it is best to use the option to 'Save as PDF'. 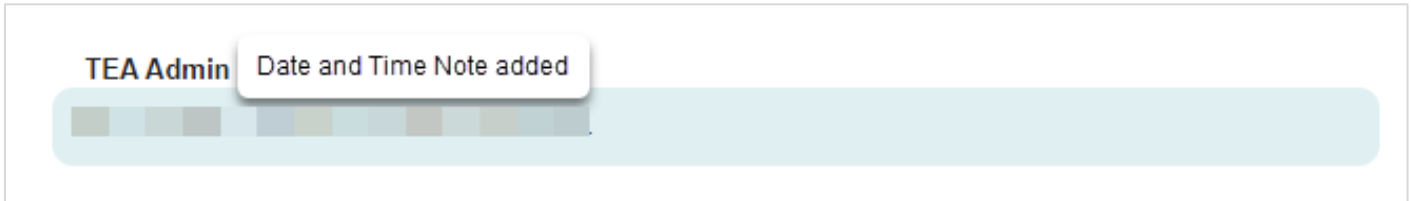

## Deleting Students

# Entering High Cost Fund (HCF) Applications

## HCF Introduction

The High Cost Fund application is used to request additional federal funds (High Cost Funds) to help offset the financial impact on LEAs that provide educational services to high-need children with disabilities. For additional information regarding High Cost Funds, including the definition of a high-need child and HCF eligibility requirements, please visit the TEA [High Cost Funds](#) webpage.

Whereas the submittal of the Nonpublic Day and Nonpublic Residential applications are **required** to notify TEA of any student whose admission, review, and dismissal (ARD) committee determines placement in a nonpublic day or nonpublic residential facility is the most appropriate educational setting for the child to receive a free, appropriate public education (FAPE) in the least restrictive environment (LRE), requesting potential additional funding (High Cost Funds) is **optional**.

**Note:** Access to High Cost Fund reimbursement awards is not guaranteed and may vary based on funding availability.

Within the HCF application, three different placement types may be included: 1) Student with a Nonpublic Day application in Finalized status, 2) Student with a Nonpublic Residential application in Finalized status, 3) In District student.

## General HCF Navigation

### Home page

The HCF **Home** page displays auto-populated application data. **No data entry** is performed by the user on the home page.

Once the HCF application has been certified and submitted by the user, the **Application Totals** section will display a summary of the total number of applications submitted and total number eligible by placement type (In District, Nonpublic Day, and Nonpublic Residential). The eligible number may change after TEA reviews, approves, and finalizes the application.

The **High Cost Funds Award Calculations** section will display the total dollar amount being requested and the total dollar amount eligible by placement type. You may see zeroes or dollar amounts displayed in this section upon the opening of the HCF application. The amounts will change as student-specific applications are completed and saved and when the application is submitted. The eligible dollar amounts may change after TEA reviews, approves, and finalizes the application.

The **SHARS Expenditure Subtracted** amount will be the sum of any School Health and Related Services (SHARS) amounts you entered on student-specific applications.

The **APPE Subtracted** amount will be the amount of the applicable state average per pupil expenditure (APPE) for that HCF application year multiplied by the number of unique student

applications you submit. For example, for the 23-24 HCF application, the APPE was \$12,529. If you submitted two unique student applications, the “APPE Subtracted” amount was \$25,058 (\$12,529 x two students). However, if a specific student had two placement types, e.g. Nonpublic Day and In District because the student was only placed in the nonpublic day school for part of the year, the application will only subtract the APPE amount once instead of twice for that student.

The **Total Amount Eligible** indicated in the **finalized** application is **not** your LEA’s HCF award amount. The eligible amount is simply the amount of the requested costs that have been approved by TEA staff as being eligible costs for HCF purposes.

The **Final Pro-Rated Award Amount** at the bottom of this section will be displayed **after** TEA determines award amounts for all HCF submissions. The award amount will be displayed in the application on the first business day in July.



Use the **Personnel Type** drop-down menu to select a personnel or contracted services type (Teacher, Aide, Related, Contracted, Other). In the **Description** box, write a brief description to provide further information. For example, if you selected "Related" as the Personnel Type, enter

The Type of Transportation you select will affect the remaining fields in the row, based on the selection type.

### Special Route Services

**Special Route Services** means transportation in which the LEA uses **their vehicle** to provide the transportation. This will be the most common option selected.

Enter the **Daily ROUND TRIP Mileage** for the student's transportation. (*This was new effective with the 23–24 application. In the past, the data entry was limited to one-way mileage and APEX determined the cost for round trip. Now, the LEA enters the round-trip mileage.*) Round trip mileage is the **average** mileage in one day for the specific student's transportation from Home to School/Facility and from School/Facility to Home.

**Note:** *If the LEA only transports the student one direction, enter the daily mileage for which the LEA is transporting this student.*

The **Annual Transportation Cost Per Student [if Special Route], Estimated State Transportation Allotment**, and **Estimated Excess Transportation Cost** fields will auto-populate. The Excess Transportation Cost is the difference between the Annual Transportation Cost and the Transportation Allotment (the FSP state transportation funds).

Private Route Services

**Private Route Services** means transportation in which the LEA **contracts** with the

parent/designated agent or uses contracted commercial transportation to provide the transportation.

Enter the **Daily ROUND TRIP Mileage** for the student's transportation. *(This was new effective with the 23-24 application. 

## Deleting and Recovering HCF Students

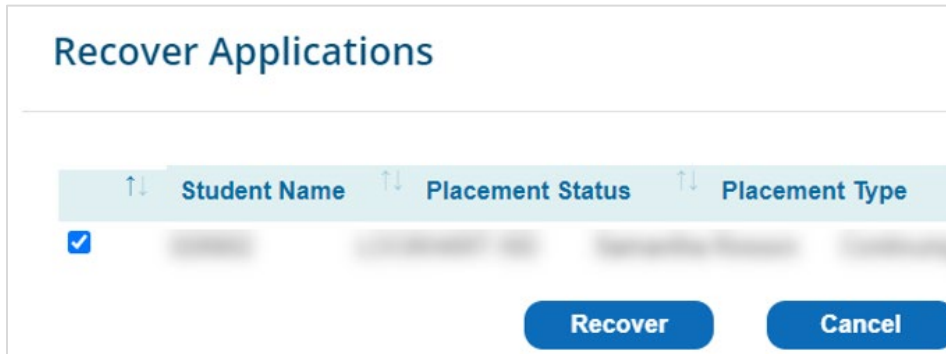

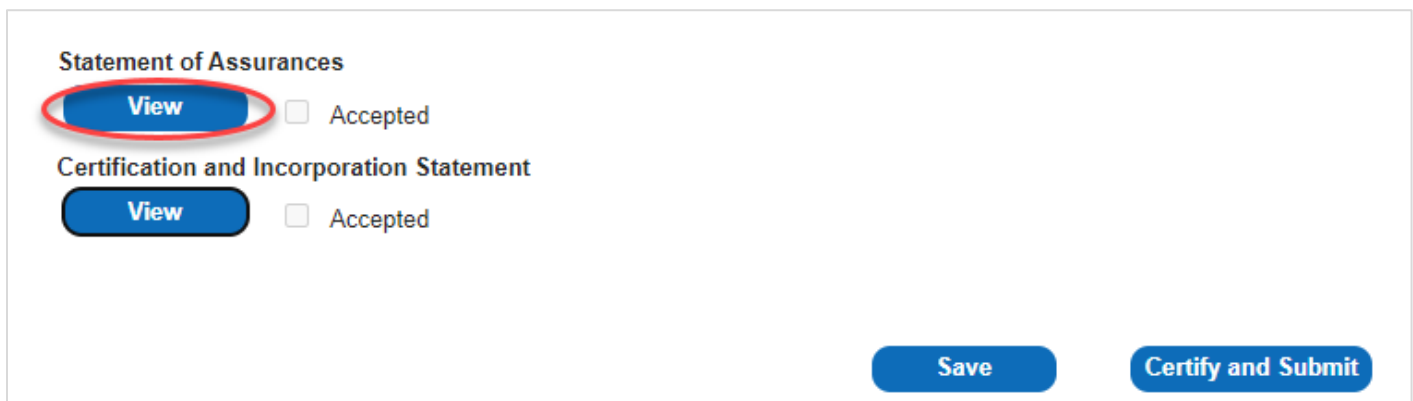

clicking **Certify and Submit**. You can also save your application at any time, without submitting it, by clicking the **Save** button. **Failure to Certify and Submit will keep the application in Pending or Clarify status.**

You will see a pop-up box affirming that the application has been successfully submitted, and an automated confirmation email will be sent to the contact listed on the HCF home page. Your application status on the top right of the **Application Summary** will read **Submitted**.

**Note:** Unlike the Nonpublic Day and Nonpublic Residential APEX applications in which each student application is certified and submitted separately, the HCF application is submitted once and comprises all HCF student applications (In District, Nonpublic Day, and Nonpublic Residential placement types) in one submission. Therefore, do **not** submit your HCF application until you have completed student application pages all students for whom you wish to request High Cost Funds.

## Clarifications

If the TEA requires changes or clarifications to your HCF application, the district contact listed on the HCF Application Summary page will receive an automated email from the APEX system notifying them that revisions are needed to the application.

In the HCF **Student Roster**, you will typically see the word **Yes** under **Clarification Required** for students for whom clarifications are needed.

At the bottom of the student's application page, expand the **Clarification/Communication Notes** section to view and respond to messages entered by TEA staff. Refer to the [Submitting Clarifications](#) section of this guide for more information about the Notes tool.

After you have responded to requested clarifications by a) revising information in the application, b) uploading additional documentation, and/or c) using the Notes field to write a response, return to the **Application Summary** page to **re-Certify and Submit**. **Failure to Certify and Submit will keep the application in Clarify or Pending status.**

## Amending the High Cost Fund Application

If you need to amend a previously submitted HCF application, click the **Amend** button at the bottom of the **Application Summary** page, under the Assurances and Certification Statements.

## Amending a Previously Finalized Day or Residential Application

If you amend a **previously finalized** Nonpublic Day or Nonpublic Residential application in the APEX system, and you have already started or submitted your HCF application for this student, the student will become non-clickable in your HCF **Student Roster** until the Nonpublic Day or Nonpublic Residential application is **resubmitted and re-finalized**. Furthermore, you will not be able to submit a pending HCF application until the student is finalized in the Nonpublic Day or Nonpublic Residential application system.

If the HCF application has already been submitted and you then amend a **previously finalized** Nonpublic Day or Nonpublic Residential application for a student that was included in the HCF application, TEA will not be able to finalize the HCF application or award funds until the Nonpublic Day or Nonpublic Residential application is **resubmitted and re-finalized**.

Conversely, if your HCF application is in **Finalized** status, you will not be able to amend finalized Nonpublic Day and Nonpublic Residential applications for students that are also included in the HCF **Student Roster**. Email the TEA HCF team at [hcf@tea.texas.gov](mailto:hcf@tea.texas.gov) for guidance and authorization.

## High Cost Fund Award Information

On the HCF **Home** Page, you will be able to view total amounts **requested** and total amounts **eligible**. Once your HCF application is finalized, the total **eligible** amounts may change. The district contact listed in your application will receive an automated email when the application is finalized.

The **Total Amount Eligible** is *not* your district's HCF award amount. The eligible amount is simply the amount of the requested costs that have been approved by TEA staff as being eligible costs for HCF purposes.

When TEA has completed **final award calculations** for all HCF submissions, you will receive an automatic email indicating the HCF has been awarded. This amount will then be visible under **Final Pro-Rated Award Amount**. The award amount will be displayed in the application by the first business day in July. LEAs will be informed by email in mid-July regarding the process for how to receive the reimbursement payment.
